SECURITY POLICE

MISSION

The mission of the Chief, Security Police, expressed in the most basic terms is to provide security and law enforcement functions to Tan Son Nhut Air Base, Republic of Vietnam. That still remains essentially stable in addition to special projects initiated either internally or by higher headquarters.

THE HOSTILE THREAT

Hostile activity remained at a low level in the Saigon/Tan Son Nhut area throughout this historical period. The primary threat to the installation was that of stand-off weapons (rockets) and sapper attacks. Again, no large enemy maneuver elements appeared to threaten the installation or its resources. (1)

OPERATIONS

At the end of the First Quarter, CY 72, the unit was undermanned by 27 personnel. During February and March, 40 TDY personnel were returned to their CONUS bases. In the month of March, this unit received approximately 25 personnel PCS from Phan Rang Air Base, Republic of Vietnam. (2)

WEAPONS SYSTEMS SECURITY

On 24 January 1972, the Weapons Systems Security Section requested that Civil Engineers remove vegetation from territory between defensive positions and the flight line. Grating was also requested at all ditch openings to stop unauthorized entry. Through follow-up action and coordination, these tasks were completed prior to TET 1972. Also in preparation for a possible offensive during TET, the following precautions were completed: additional bunkers were built in the vicinity of taxi-way W-6, several additional fighting positions were built, a concertina wire barrier was erected behind the Navy revetments, additional trip flares were installed and claymore mines were set out in strategic locations. Also from 17 January 1972 to 31 March 1972, Security Police responded to 97 aircraft emergencies. (3)

LAW ENFORCEMENT

The Law Enforcement Section processed 1125 DD Forms 1569, Incident Report, which included 673 investigative cases, 196 incidents, 44 complaints and 10 curfew violations. A total of 102 accidents were investigated and 189 traffic citations issued. On 26 February two sections, Resources Protection and Investigations relocated to building 126. (4)

The Investigation section workload remained extremely heavy. There were 100 cases involving theft of government property investigated, totaling \$49,622.00. Government property in the amount of \$49,336.00 was recovered. A total of \$16,140.00 worth of private property was reported stolen. Of this amount, \$574.00 was recovered. (5)

ADMINISTRATIVE SECURITY

A total of 55 Office of Special Investigation (OSI) cases were requested and eight Serious Incident Reports were submitted. Eighteen OSI investigations and four serious incident report were closed during this period. (6)

Some 1,067 personnel security actions were handled during this quarter. This included request for 69 personnel security investigations, 191 final security clearances and 7 interim clearances granted. A total of 890 access reviews were completed. (7)

The Pass and Registration workload for the quarter remained extremely heavy. figures of interest are the number of DD Forms 2AF that were issued (947), war trophy firearms registered (738), civilian employee passes issued (863), and POV and Contractor Vehicle Passes issued (3, 723). (8)

PERSONNEL AND MANNING

Manning remained at a generally stable level during this reporting period. Two hundred fifty-one personnel departed the organization, while 242 were newly assigned from the CONUS or In-Country transfers from other bases within the Republic of Vietnam. There were several personnel changes in the squadron. Major Lou R. Alford

became the Squadron Operations Officer on 27 January 1972. Captain Michael R. Schmunk was assigned as Squadron Section Commander, replacing Captain James M. Pirkle, on 8 February 1972. On 08 March 1972 SMSgt Keith Christianson replaced SMSgt Jaes Montoya as Aerospace System Security Superintendent. (9)

One Key position in the Law Enforcement Section was left vacant when Captain Stephen C. Mannell, OIC of Law Enforcement Operations, departed PCS on 26 March 1972. His replacement is not due to arrive this station until 28 April 1972. The Law Enforcement Section currently has two Law Enforcement Superintendents, SMSgt Stephen Porovich assigned on 04 February 1972 and SMSgt Calvin C. Moreland. (10)

SPECIAL ACTIVITIES

On 01 March 1972, the Squadron Drug Abuse Council introduced a new innovation to their program. Personnel from Key organizations on Tan Son Nhut Air Base such as the Chaplain's Office, Base Dispensary, Base Legal Office, and Law Enforcement were set up as a panel. Members of the council surveyed personnel in the squadron to obtain pertinent questions that they wanted to present to the panel about drugs. The questions were presented and a resume of the subsequent discussion distributed throughout the squadron. (11)

Also on 11 March 1972, the Squadron Human Relations Council was reorganized. A more equitable distribution was established between NCO Supervisors and Airmen.

SUMMARY

There were no Significant Changes in the Squadron operation from 17 January 1972 to 31 March 1972. No enemy attacks were encountered and no indication of any large build up of enemy forces was detected. In March 1972 the Chief of Security Police and the Administrative Security Section moved from building 123 to building 19A. At the same time the Operations Section relocated to building 41. The Investigation Section and Pass and Identification Section moved to building 126 on 26 February 1972.

Manning remained stable and 40 TDY personnel were returned to their CONUS bases. There were several key personnel changes to include the squadron operations officer, the squadron section commander and the OIC and the NCOIC of both the Law Enforcement and Weapons Systems Security Sections.

Programs dealing with "people" such as Human relations and drug abuse received increased emphasis. The drug abuse council is being conducted by squadron members

and

monitored by command. This give the airmen an opportunity to direct their own program to meet their needs as they see them. The Human Relation Council established as its goal, the improvement of communications throughout the squadron.
